

# **PRIVACY POLICY**

#### Personal identification information

#### Non-Personal identification information

Non-personal identification information may include the browser name, the type of computer or smart device and technical information about the User's means of connection to our Site(s), such as the operating system and the Internet service provider's utilized and other similar information.
